



## **NEDBANK LESOTHO DIGITAL TRANSACT AND WIN COMPETITION 2021 TERMS & CONDITIONS, RULES AND REGULATIONS**

These Rules and Regulations (“Rules”) for Nedbank Lesotho’s (the Bank) **Digital Transact and Win Competition** 2021 (the Competition) are part of the Terms and Conditions of Use & Privacy Policy (the “Terms and Conditions”) that govern the competition. The Competition is administered by Nedbank Lesotho, and is open to all Nedbank Lesotho clients with active accounts, who are aged 18 years and above at the time of entering the Competition. The Competition will run from 01 February 2021 and close at 12:00 midnight on 30 April 2021 (“the Campaign period”). Winners will be announced regularly through various Nedbank communication channels.

### **Eligibility Requirements**

1. The Competition is open to all Nedbank Lesotho clients with active accounts, who are aged 18 and above at the time of entering the Competition (herein defined as “Participants”).
2. To qualify, Participants must perform any one of the following transactions (“Digital Transaction”) on the Nedbank Money App (Africa) or Nedbank Online Banking, within the campaign period:
  - a. Make a Payment (Nedbank to Nedbank, Nedbank to other bank), or account transfer
  - b. Send cash using Nedbank SendMoney
  - c. Buy Prepaid airtime or electricity.
3. Participants can transact on the Nedbank Money App (Africa) and Nedbank Online Banking as many times as they want.
4. Each transaction is considered as a single entry. The more a participant transacts, the greater their chances of winning.
5. Nedbank Lesotho staff members including temporary staff and agencies are **not** eligible to participate in the Competition.

### **Permissions and Releases**

By making a Digital Transaction between the months of 01 February 2021 to 30 April 2021, participants are automatically entered into the Competition.

### **Judging Process**

1. Winners will be selected based on a weekly random draw and on the number of Digital Transactions
2. There will be two (2) winners per week
3. The Lucky Draw will be a random draw from a selection of all clients who have done any qualifying digital transaction during the Competition week. The higher the number of transactions a client does, the higher their chances of winning in any particular week.
4. The decisions of the Nedbank Lesotho Judging Panel are final and not subject to negotiations, challenge, or appeal.



### **Judging Criteria**

The judging of the Competition will be based on a random draw of the Digital Transactions done by clients during every week.

### **Prizes**

The 2 winners will each receive M1,000.00 (One Thousand Maloti only) deposited into their active Nedbank account opened in the winner's name.

Prizes are not transferable and cannot be traded in and must be received on an "as-is-basis".

### **Intellectual Property**

By making a Digital Transaction between the months of 01 February 2021 and 30 APRIL 2021, Participants automatically get entered into the Competition. Nedbank Lesotho will get participants' consent before sharing their identity with the public should they be winners in the Competition. Nedbank Lesotho will not share Participants' personal banking information with anyone.

- The Competition is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter or any other platform where it is advertised. The Competition is administered by Nedbank Lesotho.
- Participants agree to release Nedbank Lesotho and any platform where the Competition is advertised, from all claims, demands, and damages of every kind and nature, known and unknown, arising out of or in any way connected with the Competition and the Participant's participation.

### **No Recourse to Judicial Procedures**

To the extent permitted by law, the rights to litigate, to seek injunctive relief or to any other recourse to judicial procedure in case of disputes or claims resulting from or in connection with this Competition are hereby excluded, and Participants expressly waive any and all such rights.

### **Preservation of Immunities**

Nothing herein shall constitute or be considered to be a limitation upon or a waiver of the privileges and immunities of Nedbank Lesotho, or any member of the Bank, which are specifically reserved.

### **Competition Terms**

By making a Digital Transaction between the months of 01 February 2021 and 30 April 2021, every Participant agrees and accepts that:

- The Competition is open only to Nedbank clients with active accounts;
- Participants entering the Competition must be 18 years of age or older;
- The decisions of the Nedbank Lesotho Judging Panel are final and are not subject to any appeal;



- Participants agree that Nedbank Lesotho may publish information after obtaining consent, such as Participants' names and biographical information, videos and/or derived content on Nedbank Lesotho webpages and through blogposts, newsletters, articles, social media platforms and any other communication channels and public display;
- Participants agree that Nedbank Lesotho may publish information such as Participants' names and biographical information and/or videos with partners and partner organizations only for the purpose of those individuals and organizations to publicly display and broadcast this information/content;
- Participants waive all claims against the Bank, its personnel and agents arising out of any oral or written publication or republication of any statement made in connection with the Competition, their person or entry to the Competition, or video;
